Dear Secretary Bose:

In accordance with the requirements of the Interstate Commerce Act (“ICA”) and the Rules and Regulations of the Federal Energy Regulatory Commission (“FERC” or the “Commission”), in particular Sections 342.3 (Indexing), 18 C.F.R. §§ 342.3 (2023), Paline Pipeline Company, LLC (“Paline”) submits for filing the following tariffs, to be effective July 1, 2023:

FERC No. 1.18.0, canceling FERC No. 1.17.0 (Docket No. IS22-889)
FERC No. 2.17.0, canceling FERC No. 2.16.1 (Docket No. IS23-213)

As marked in the enclosed proposed tariffs, and as illustrated on Schedule A hereto, the rates are modified in accordance with the tariff rate indexing provisions of 18 C.F.R. § 342.3. Each of the rates are equal to the corresponding new ceiling level calculated in accordance with 18 C.F.R. § 342.3(d) using the index multiplier of 1.133194 set by the Commission on May 16, 2023 in Docket No. RM93-11-000 for the period from July 1, 2023 through June 30, 2024.¹

In accordance with the requirements of 18 C.F.R. § 342.3(b), Schedule A sets forth the proposed new rate, the prior rate, the prior ceiling level, and the applicable ceiling level for each route in the proposed tariffs.
